PART I. General Expectations

Travis Middle School agrees to implement the following statutory requirements:

PART II. Description of how Travis Middle School will implement the required components of the campus Title I Parent Engagement Plan.

1. Travis Middle School will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Parents are invited to be part of a Parent Advisory Committee. These meetings are held annually. Parents are selected by principals and counselors. Parents are also chosen from volunteer sign-in sheets that are available at open house and other parent events. Translators are available as needed

2. Travis Middle School will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Parents are invited according to the volunteer sign in sheets offered throughout the year. The principal discusses what is expected of them and if they agree to serve. Translation is always available.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - All staff is trained during professional development at the beginning of the school year and documented.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Travis Middle School will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- All parents are invited by printed invitation and school messenger to come to Open House. Prior to going to classrooms, a meeting is held in the auditorium and Title I is explained by the principal. Translation is always available. The Parent-Teacher Compact is printed in English and Spanish and distributed at this time.

4. Travis Middle School will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Title I parent meeting
- ARD meetings
- Academic nights
- Ongoing parent communication throughout the year
- Parent/Teacher meetings
- Translation is always available

5. Travis Sixth Middle School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possibly. These may include, but are not limited to, the following:

- Parents are encouraged to offer suggestions to teachers and staff throughout the year. Parent surveys are available at every parent event. Suggestions from these surveys are used. A parent meeting on various topics is held at least once a month. Translation is always available.

6. Travis Middle School will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Parents may view student grades and scores thru skyward Family Access.

7. Travis Middle School will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with teachers to understand expectations
- Dress code
- Understanding school rules

8. Travis Middle School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night.
- Math Night.
- Science Night.
- Discovery Center Night.
- Skyward Parent Training.
- Parent engagement programs.
- Open House

- Meet and Greet
- United Way Family Night
- Band, orchestra and choir parent nights

9. Travis Middle School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Weekly staff development meetings
- Collaboration meetings
- Monthly grade level meetings
- Trainings offered throughout the year for teachers

10. Travis Middle School will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- All incoming seventh grade students and families receive a home visit from teachers and principals prior to the beginning of school to welcome them to Travis Middle School.

11. Travis Middle School will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Translators are available at registration for languages other than Spanish. ELSA messaging system is used to communicate with parents. Every effort is made to communicate with parents in their language.

PART III. Discretionary Components of the Travis Middle School Title I Parent Engagement Plan

Travis Middle School may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
